4. Mileage

Mileage displayed in an advertisement is based on the odometer reading and information reasonably available to us at the time the vehicle is advertised.

Mileage may increase after a vehicle is advertised due to movement, preparation, servicing, testing, demonstrations or test drives.

Where mileage is particularly important to a customer, the current mileage should be confirmed with Sipson Cars Limited before purchase.

5. Vehicle History
